**VENDOR REGISTRATION**

Setup begins at 7:00 a.m. the day of the fair and must be completed by the time the fair opens. Vendors only during set up hours. Fair hours are 10:00 a.m. to 4:00 p.m. Vendors should be in their vendor location prior to start time. Vendors are not to sell food for human consumption. Nothing can be attached in any way to the walls, vendors are financially responsible for any damage they do to the building. **It is requested that each vendor donate an item for the raffle table.** 25% of the fair profits will go to an avian cause. Vendors may not sublet or resell their table space. Vendors are expected not to "break down" tables during show hours. Vendors must not prop exterior doors open during fair hours. Clean up/breakdown begins at 4:00 p.m. **and must be completed by 6:00 p.m.** All vendor property must be removed from the facility by the end of breakdown. Violation of any part of this agreement may result in the immediate ejection of the vendor responsible.

NO tables will be reserved without payment. All tables are on a first paid first reserved basis. Wall space and end tables are limited and sells out quickly. Please bring your own extension cords if you reserve an electric accessible table and **please supply your own table cover.** Tables are 2 X 8. Payments made prior to March 17<sup>th</sup> can be by personal check, after that date a money order is required. Table rentals are final, **NO REFUNDS**, and tables are not transferable. No charge for chairs. Please keep safety in mind if stacking cages. The majority of items displayed must be bird related. Children must be supervised.

Vendors selling live birds agree to house them in clean conditions with access to food and water, and will not overcrowd their birds. Vendors agree to keep their area neat and clean and only display healthy birds: birds that are questionable will not be allowed in. It is suggested that wings be clipped. **MICHIANA BIRD SOCIETY DOES NOT CONDONE THE SALE OF UNWEANED BABY BIRDS.**
